

Sunny Dispositions – Airbrush Tanning Client Consent Form

Please review the following information and acknowledge your understanding and agreement by signing below before participating in an airbrush tanning session to achieve a “sunless” tan.

- Airbrush tanning is accomplished by application of a solution containing the active ingredient DHA – Dihydroxyacetone. This ingredient is derived from sugarcane. DHA is considered to be safe and has been FDA approved for cosmetic and external use only with the following recommendations:
 - It is recommended that you use protective garments, eyewear, nose filters, and lip (such as lip balm) protection prior to our service. All protective measures are available from your esthetician.
- If you have sensitive skin or allergies to sunless tanning products containing DHA, or if you are unsure whether you may be allergic to any ingredients in our solutions, we strongly recommend you consult your physician prior to tanning. Also, please note some of our solutions contain almond and walnut extract.
 - Allergic reactions such as minor skin rash are extremely rare, but possible. If you have never used a sunless tanning product, we suggest a patch test 24 hours before your full body application. Sunny Dispositions, Advanced Skincare Services, LLC is not responsible for any allergic reactions that may occur after or during use.
- If you have a history of asthma or respiratory medical condition it could be aggravated by the airbrush tanning process. Please consult your physician before proceeding. Also if you are pregnant or nursing it is suggested that you consult your physician for permission prior to your airbrush tan.
 - Please advise your esthetician of any allergic reactions with DHA products or other medical concerns. Sunny Dispositions, Advanced Skincare Services, LLC is not responsible for any medical conditions that may occur during or after use.
 - Some ingredients in our solution contain a sugar-base and may reason a rise in blood sugar levels. If you are diabetic or have a medical condition that can be affected or aggravated by a rise in blood sugar, please consult your physician before use.
- The bronzer and tanning solutions used during your session have the potential to stain clothing. We recommend that you wear dark clothing for your appointment, such as an old swimsuit or undergarments. We suggest bringing a towel to cover your car seat. For your convenience, disposable thong and bra garments are available for your use and are available upon request. After your tanning session, you should wear **loose** fitting clothing and flip flops.
 - It is also possible that the solutions may transfer to other clothing, furniture or car seats after your session. Laundering garments will usually remove the solution transfer or bronzer. Sunny Dispositions, Advanced Skincare Services, LLC is not responsible for potential clothing or upholstery stains.
- Your tanning session will take approximately 10 to 15 minutes and will include the application of a pretreatment pH Balancing Solution and Barrier Cream. After spray tanning, your skin should be dry before dressing. We will provide you with a hair dryer to assist you in this drying process.
- You should NOT bathe, shower or sweat excessively for 8 -10 hours after your Airbrush Tanning Session. Exposure to excessive moisture during this development process may affect your results. Do not apply any products to the skin during this development process.
- Since the Airbrush Solution is formulated with a cosmetic bronzing ingredient, your skin will look bronzed. This is an immediate but temporary affect. The true color of your tan is revealed after you shower and remove the bronzer. Please wait at least 8 – 10 hours to shower and rinse the skin with warm water and avoid using any soap or shower gels at this time.

- It is suggested that you use pH balanced shower gels and tan extenders to keep your tan fresh and vibrant. You can expect your tan to last 5 – 7+ days. The longevity of your tan is determined by how well you have prepared your skin with exfoliation products prior to your session and the moisture level of the skin after. Sunny Dispositions, Advanced Skincare Services, LLC offers a variety of pre and post care organic products.

2. The airbrush tanning process has been explained to me and I hereby agree to allow Sunny Dispositions, Advanced Skincare Services, LLC to apply spray tan solution to my skin using the airbrush tanning process.
3. I understand that this product does not contain a sunscreen and does not protect against sunburn.
4. To my knowledge, I have no medical condition or allergy which would preclude me from having this procedure done.
5. I agree to hold harmless Sunny Dispositions, Advanced Skincare Services, LLC of any medical complications that may arise and I have been advised to discontinue use if any reaction occurs.
6. I understand that the results of an airbrush tan do vary and that no guarantees of specific results are offered or implied.
7. I hereby release this establishment, as well as the esthetician, and hold them harmless from any liability involved in the use of or arising during the tanning process.
8. I also agree to contact Sunny Dispositions, Advanced Skincare Services, LLC if for any reason I am dissatisfied with my results.
